The Junior League of Columbus operates the Kelton House Museum and Garden, which proudly features the Underground Railroad Learning Station located in the Discovery District of Columbus, Ohio. The Museum provides the public with a unique view of urban life and the decorative arts during the second half of the 19th century, largely through the collection of the Kelton Family. During the fiscal year ended June 30, 2025, the Kelton House Museum and Garden received approximately 4,300 visits.

The Junior League of Columbus' community projects include our signature project, Bridging the G.A.P., which focuses on support and advocacy efforts for youth aging out of foster care through three focused avenues - Guide, Advocate, and Provide. The guidance on accounting for uncertainty in income taxes also addresses de-recognition, classification, interest and penalties on income taxes, and accounting in interim periods. On June 30, 2025, there were no
