The Junior League of Columbus operates the Kelton House Museum and Garden, which proudly features the Underground Railroad Learning Station located in the Discovery District of Columbus, Ohio. The Museum provides the public with a unique view of urban life and the decorative arts during the second half of the 19th century, largely through the collection of the Kelton Family. During the fiscal year ended June 30, 2024, the Kelton House Museum and Garden received approximately 5,300 visits.

The Junior League of Columbus' community projects include our signature project, Bridging the G.A.P., which focuses on support and advocacy efforts for youth aging out of foster care through three focused avenues - Guide, Advocate, and Provide. The JLC also devotes significant volunteer time and provides quick impact grants to partner nonprofits who reflect and support the Junior League's mission.

The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. The guidance on accounting for uncertainty in income taxes also addresses de-recognition, classification, interest and penalties on income taxes, and accounting in interim periods. On June 30, 2024, there were no material unrecognized tax benefits identified or recorded as liabilities.

The Organization files Form 990 in the U.S. federal jurisdiction and the state of Ohio. The Organization's federal exempt organization tax returns are subject to examination by the Internal Revenue Service, generally for three years after they are filed. All tax returns for years ending after December 31, 2021 are open for examination.
